- I. General provisions
  - The following terms modify the mutual terms between the rights and duty of the operator and registred users in the context of the offer of the sports betting advice provided by Simplicityinvestments. Inc
  - The service that is offered by Simplicityinvestments. Inc is defined as sending picks on the results of the sport games. Sport picks from Simplicityinvestments. Inc have a purely informative character and nothing else. Simplicityinvestments. Inc is not liable for any damage that may arise due to the use of our sport picks be it in a direct or indirect way.
  - All sport picks from Simplicityinvestments. Inc are just recommendations and it is solely the user's decision whether the picks are used or not.
  - By registration to the membership section of Simplicityinvestments. Inc the user confirms that he/she has read terms, understands them and fully agrees with them
- II. Registration
  - Only a person who is at least 18 years old has the right to register in the system of Simplicityinvestments. Inc
  - The provider reserves the right to cancel registration in case of a registration that is obviously fictituous or duplicit, or if the person has violated any of the terms in the past.

## III. Payment Conditions

- It is possible to pay for services of Simplicityinvestments.inc through the payment gate, Skrill or by bank transfer.
- All payments are accepted in CZK, USD or EUR currency. If the user sends money in any other currency, all the charges connected to currency conversion will be deducted from the bank account of the user.
- The user agrees to pay up all the charges that are connected to his selection of the payment method. The amount of the final costs will be displayed on the user's order summary and a copy of this will be sent to the buyer.
- The contract between the user and Simplicityinvestments. Inc is valid at the moment when the money sent by the user for services of Simplicityinvestments. Inc has been successfuly added to the bank account of Simplicityinvestmentments. Inc. Payment confirmation including order summary will be sent to the e-mail address provided by the user during registration.
- Simplicity investments have the right to step down from a contract in the case:
  - 1. It is not possible to provide advisory on the original terms or from objective cause.
  - 2. At the time of registration, the price for Simplicityinvestents.Inc service wasn't correctly set up and therefore the contract is invalid.
  - 3. A member violates any point of terms.
- In case Simplicityinvestments. Inc decide to step down from a contract, the member will be informed by the e-mail that has been provided during registration. If financial payment for Simplicityinvestments. Inc services has already been made, the money will be returned within 14 days to the bank account provided by the member.
- If the contract is cancelled during valid membership the money returned will be relative to the days used of the 30 days membership payment. Membership is officially cancelled the day in which the request for cancellation has been sent to Simplicityinvestments. Inc

## IV. Delivery Conditions

- The membership that has been ordered will be activated the moment the correct funds have been added to the bank account of Simplicityinvestments. Inc. At the latest, this will be within 48 hours of a working day.
- Services that are possible to buy from Simplicityinvestments. Inc for money will be available the moment payment for services have been added to the bank account of Simplicityinvestments. Inc

## V. Rights and Duties

- Simplicity investments. Inc as a website provider will provide membership from the moment a contract has been made and as long as the contract is valid. Active membership is used to pay for advisory services.
- Duties of the member include strict prohibition from sharing the sport picks to a third party. In the case that a member violates this point he/she is bound to pay a fine of 40,000 USD.
- If the picks are given to a third party the claim for compensation by Simplicity investments. Inc will be issued and registered users must accept the full amount, with no grounds of exception
- Simplicity investments. Inc sequester the right to step back from a contract in the case that a member rejects monthly financial charging to Simplicity investments. Inc for which Simplicity investments. Inc have entitlement in case of a closed contract.
- Members' internet connection is controlled through the proof of IP address. Therefore, if there is any suspicion or it will be proven that more than one user uses an account Simplicityinvestments. Inc sequester the right to close the account without any right for refund.
- Funds in the case of a negative balance are not returned to the user.
- VI. Final provisions
  - The member agrees to handover the e-mail address and phone number to Simplicityinvestments. Inc for the reason of communication.
  - Simplicity investments ensure that all the personal details will not be given to a third party with the exception of an agency active in criminal control.
  - For this contract, the communication means for the entire duration of the contract is set in place (PC, internet, mobile phone etc.). The member fully understands that expenses for the conclusion of the contract are paid by him/herself. Therefore no claim for the payment of these expenses has been created.
  - All changes in the contract wil be done one-sidedly without member agreement. Changes are valid on the 5th day after the e-mail about the summary of changes has been sent. If any changes are made for current terms, the member will be informed by e-mail. In the case of disagreement with changes, the user is allowed to step back from the contract and ask for a cancellation of his/her membership.
  - If there is anything that is not clear or any discrepancy occurs, the member can contact Simplicityinvestments.inc directly through the e-mail address.

• Rights and duties that do not result from the terms are driven by legal regulations of the Seychel Republic and her citizen law, including a jurisdiction trial for any possible trial dispute. In a legal dispute, the rights of the Czech Republic is excluded, including the use of Czech civil code.
